A Violent Arrest

At 6am the morning of March 20th, four CBSA agents forced their way into the home of Lucy Francineth Granados, a neighbour and community member who had lived in Montreal for 9 years. They proceeded to violently arrest her, throwing Lucy onto a table and then the ground, twisting her arm while an agent held her down with a knee pressed into her back. They then brought her to the Laval Immigration Detention Centre, where she was detained pending deportation. Her treatment provoked a health crisis: she was twice hospitalized, the first time after suffering a cardiac arrest. Four medical specialists recommended she not be deported in this state. On Friday, April 13th, Lucy was nevertheless deported to Guatemala, accompanied by two CBSA agents and a nurse, with only the clothes on her back. Her arm was still partially immobilized and her hand swollen; her neck and her back were bruised and she had a persistent chest pain.

Who is Lucy and Why was she treated this way?

Lucy Francineth Granados was one of hundreds of thousands of undocumented migrants living in Canada. Like many others, Lucy left her home country of Guatemala because the situation for her and her family was increasingly difficult. Criminal gangs in her area, known as the maras, were a constant threat. Four members of Lucy's family were killed by these gangs. After her husband died in an accident, Lucy struggled to support her three children alone. When members of the maras began extorting money from Lucy, she sought safety and a way to support her children. She boarded a freight train known as La Bestia or death train (because of the large number of migrants who die on it every year), to cross Mexico and arrive in the United States, finally reaching Canada in 2009.

But Canada's refugee system failed Lucy. Her application for asylum was refused and she was ordered deported. Lucy made the courageous decision to defy the deportation order, and in 2012 joined the ranks of Canada's undocumented - those who live and work in the shadows, surviving precariously, always at risk of arrest and deportation and excluded from even basic rights and services.

Lucy joined the Montreal Non Status Women's Collective and the ATTAP (Association of Temporary Workers) to work for the rights of migrants. In 2017, Lucy filed an application for permanent residence on humanitarian and compassionate grounds, the only way undocumented residents can regularize their status. In January 2018, a CBSA officer called Lucy's lawyer and threatened that her application for permanent residence would not be processed if she did not turn herself in to be deported. This false and illegal threat on the part of the CBSA threw Lucy into a state of extreme anxiety. Two months later, the CBSA succeeded in tracking Lucy down, arresting her at her home.

For four weeks after her arrest, friends and supporters of Lucy worked tirelessly to prevent the CBSA from tearing our community apart through this deportation. A multitude of actions were organized: visits to MP offices, mass phone calls and emails to Ministers Hussen and Goodale's offices, open letters and articles;
